The Company provides engineering design, application and/or field service solutions in a wide variety of industries involving electrical systems, electric motors, motor control panels and drive systems to customers and assembles such systems for customers. Customer desires to procure such services and purchase such products from the Company. The Company is willing to perform such services for and sell such products to Customer, subject to the conditions that the Company makes no warranties of any kind or nature with respect to such services and products. The parties therefore agree as follows:
2. Pass Through of Manufacturer's Warranties. Equipment components manufactured by others may be covered by separate warranties of the manufacturer but are not warranted by the Company. To the extent permitted by applicable law, the Company hereby assigns to Customer any and all rights it may have under any express or implied warranty made to the Company by the manufacturer or seller thereof with respect to any product purchased by Customer. If any such product shall be defective, the Company shall furnish to Customer, upon written demand, copies of all instruments, if any, relating to warranties made by the manufacturer or seller thereof to the Company covering such product. To the extent the assignment of such rights is not permitted by applicable law or is not effective to accomplish its purpose, the Company shall, at Customer's expense, use its best efforts to enforce the same forth benefit of Customer.
3. Elimination of Company Warranties.
